From Columbia and the eastern part of the state: take I-26 west toward Spartanburg. Take Exit 104 (Piney Grove Road) and turn left. Proceed approximately 1.5 miles to St. Andrews Road. Turn right, then left at the first traffic light. Saluda Shoals Park is 1.5 miles on your left. Once you are in the park, after you pass the check in desk, follow to the stop sign. Go straight to get to the River Center and follow the signs.



From the Upstate: take I-26 east toward Charleston. Take Exit 104 (Piney Grove Road) and turn right. Proceed approximately 1.4 miles to St. Andrews Road. Turn right, then left at the first traffic light. Saluda Shoals Park is 1.5 miles on your left. Once you are in the park, after you pass the check in desk, follow to the stop sign. Go straight to get to the River Center and follow the signs.
