# CAMP BUCKHORN, PARIS MOUNTAIN STATE PARK Greenville, SC

Paris Mountain State Park, Greenville, SC, one of the oldest protected areas in the state is gaining popularity as a beautiful retreat in a metropolitan area. Formerly a watershed for the city of Greenville, the 1540acre Paris Mountain features large




stands of old growth hardwood forests that canopy over hiking and biking trails, a family campground, picnic areas and Camp Buckhorn, a group-camp complex. Paris Mountain State Park was developed in 1935 by the Civilian Conservation Corps (CCC), a New Deal Program created by President Franklin D. Roosevelt. The CCC was instrumental in the development of many of South Carolina's state parks. A number of buildings built by the CCC in the 1930s are still in use at the park along with the lakes and dams built by the Paris Mountain water company in the late 19th century which make this park a historic district on the National Register. *Driving Directions:* From I-385: Take exit onto N. Pleasantburg Dr., (Hwy 291) for approximately 4 miles. Take a right on Piney Mountain Rd. Go to the 1st light and turn right. Park is 2 mi. ahead on the left. Cabins: We always have a lot of fun and fellowship with great food from each corner of the state! Plan to come for the weekend and bring your family. The camp lodge offers a full kitchen with basic cooking and eating utensils, a meeting room, sleeping room, a restroom, and shower facilities for men and women. 

**District 5:** Mr. Burnett Jenkins's written report stated that the Tri-County Chapter meets the first Tuesday of the month at 6:30 PM at the White Horse Restaurant in Rock Hill with an average attendance of twenty members and two guests. Overall, Tri-county has had a good year with attendance continuing to grow. District 6: No report.

#### **COMMITTEE REPORTS:**

Activities: Mr. Lewis Moore reminded everyone present of the cookout immediately following the meeting at Sullivan's Island and sponsored by Duncan-Parnell.

**Constitution and By-Laws:** Mr. Ronnie Tyler reported that his committee is still working on the wording for the changes to membership in the Constitution. He welcomes ideas from the other members.

**2009 Convention:** Mr. Lewis Moore reported that convention will be June 10-13, 2009 at the Kingston with more information to come at a later date.

**Education:** Mrs. Brenda Smith and Mr. Aaron Taylor reported that the committee is working on the February Seminars and the planning stage is almost complete with classes and speakers being finalized.

Ethics & Standards of Practice: Mr. Bobby Foster questioned on surveying the wetlands line in the changes to the Standards of Practice. After a discussion on out of state businesses doing business in SC without a state license, State Board representative, Mr. Gene Dinkins, said that all provisions are being enforced at LLR and complaints should be given to the board in writing and will be followed up on by the investigator.

Four-Year Degree Program: Mr. Bart Dominick's written report stated USC's Geography Dept. will probably start teaching surveying once it is released from the Civil Dept. That will allow almost every surveying related course except AutoCAD and Road Design to be housed in the Geography Dept. They are going forward with establishing the Surveying Minor. Courses have been proposed and were waiting on approval. USC Upstate still has their 2+2 Engineering Management Degree that will take in Civil Engr. Tech Degrees for a 4 year degree. USC Columbia still has the Interdisciplinary Degree for people with any 2 year degree, but those with Civil Engr. Tech Degrees may take 5 geography courses and 5 small business courses (or 5 civil courses with all prerequisites being met and permission from the civil dept.) and receive a 4 year degree and meet state requirements. Clemson is supposed to have a surveying option added to their Forestry Degree. GPS/VRS: No report.

**Insurance:** No report. Mr. Lee Frank reported that Chairman Dennis Clinkscales has been working on officer and directors as well as event insurance information.

**Legislative:** Mr. Ben Christensen reported that the hearings on LLR boards losing their decision making powers to and administrative

law court have been postponed. The boards being targeted were the ones for less precise and professional services than surveying.

**Membership:** Mr. Lewis Moore gave the membership report. The society currently has 480 total members. Peter M. Wagenaar, Keck & Wood, Inc., in Rock Hill was approved as a full member at the November board meeting. Presently, 54 members from 2007-2008 have not renewed. Termination letters are scheduled to be sent in the coming week.

**Newsletter:** Dale Swygert stated that he will be working on the content for the third issue. Anyone with an article to submit needs to do so by the end of December, beginning of January.

**Past President's Council:** Mr. Robert Foster indicated he had an issue with the DOT that he was trying to get in touch with Joe Jones about. The DOT is introducing a program that will allow outside users to have access to the state's road plans and it should be in place by March, 2009. Surveyors are currently having trouble getting plans from the DOT. Mr. Foster feels like it may be best to address this issue from a political angle because the DOT is currently being run by Buck Limehouse and the governor's council. Mr. Christensen said he will talk to Mr. Jones about working on this issue on the society's behalf.

#### Plat Contest: No report.

**Public Relations:** President Frank gave the report on behalf of Mr. Chuck Dawley who is working on Social for this afternoon at The Fish Fry Shack. Mr. Dawley would like some suggestions on information or people to contact to better get information out to the public about the surveying profession.

#### ROD Liaison: No report.

**S. C. State Parks:** Mr. Mike Culler's written report gave the following updates: Kings Mountain State Park – Mr. Jetter Pittman has received the information on Kings Mountain and plans to start surveying soon; Myrtle Beach State Park – Mr. Mike Culler has completed; Paris Mountain State Park – Mr. Bobby Foster and Mr. Bryan Gosnell have started surveying on one property line of the park; Santee State Park – Mr. Rod Vaughn is still waiting to hear from the state park officials for an answer on the section that has an encroachment; Sesquicentennial State Park – Joe McIntyre has no change from July 9, 2008 report.

**Scholarship:** Mr. Burnett Jenkins' written report stated that ticket sales have been slow so far. Tickets were available at today's meeting. Items to be raffled at the 50th annual convention are a Remington shotgun with commemorative etchings and a Wii Game system and 19" HDTV valued at \$575.00. Items will be raffled at the 2009 Trade Show and Conference to be announced at a later date.

**Survey Contest:** No report. Upper Piedmont will plan to games for the convention.

**Surveyor of the Year:** Mr. Dale Swygert stated that information will be posted in the newsletter for the 2009 Surveyor of the Year. **Website:** Mr. Dale Swygert reported that he is working on the content on the website and if anyone has something they would like to add they should let him know. A calendar for 2009 should be up and operational by the end of this year.

**Yearbook:** Mr. Robert Praete's written report said that the new yearbook should start delivery sometime the first of next week. Approximately 516 yearbook inserts will be mailed this year. Mrs. Brenda Smith reminded everyone that this is only the insert and that

they should keep their binders each year.

#### **BUSINESS:**

**State Board Report:** State Board Report given by Mr. Gene Dinkins. Items discussed are as follows:

• The board has adopted a policy statement that only allows only South Carolina engineers or licensed surveyors to generate DTM data.

• Regarding the issue of senate subcommittee hearings to restructure LLR boards from the state and streamlining them to give their powers to and administrative law judge – If the issue arises again the Surveying and Engineering Board plan to ask the subcommittee to establish tiers and keep surveying on the professional tier. President Frank commented the implementation of a four-year degree requirement would help insure the location of surveying on that tier.

• New regulations have been sent to legislation. SCANA expressed concern over the last line of the regulation that calls for wetlands being put on a plat by a surveyor. Because SCANA is using sketches and not actual plats, there is no problem with what they are doing at present. Minimum Standards do not require that you put wetlands on the plat. Discussion followed on how surveyors annotate wetlands on a plat that were not surveyed as a part of that plat.

All state board members were voluntarily audited and all passed.
Four Year Degree – Details are in the 4 year degree committee report. Col. Dion from The Citadel would like someone to talk to Col. Dennis Fallon about offering more surveying classes at The Citadel. With so many classes already in place, adding a couple more may allow them to offer surveying as a minor. The Citadel's night college would allow students that are not a part of the core of cadets a chance to participate in the surveying program. Mr. Dinkins will work this out with The Citadel.

• The state board approved \$3,000 to bring in a guest speaker to the February conference and \$3,000 to bring in a speaker to the engineering conference in March, 2009.

• A licensing ceremony will be held January 20, 2009 at the statehouse. All are welcome to attend.

• The state board would like to see the Society get involved in composing a new state exam. Mr. Dinkins will be glad to lend assistance for this project.

President Frank asked for a group that would be interested in acting as a liaison between OCRM and surveyors. Mrs. Frances Manhardt said that the Coastal Chapter was planning to send a letter to OCRM outlining their specific concerns. President Frank asked that the letter be sent on the state level rather then the local level so the Society and Chapter efforts are coordinated. After discussion it was determined that Mr. Chuck Dawley would be contacted about possibly chairing that committee. Mrs. Manhardt offered her assistance.

Motion to adjourn was made, seconded and unanimously approved.



# DEADLINE: MAY 1, 2009

(As approved by the SCSPLS Board of Directors November 7, 1997)

# A. Eligibility

- 1. Licensed in South Carolina.
- 2. Resident of South Carolina.
- 3. Prior recipients are ineligible for five (5) years.
- 4. No record of administered disciplinary action by the S.C. State Board of Registration for Professional Engineers and Land Surveyors.
- 5. Must be a member of the South Carolina Society of Professional Land Surveyors.

# **B.** Nominations

## **SCSPLS** Chapter

- (a) Nomination letter must have signature of Chapter President and another Chapter elected officer.
- (b) Only one nomination per Chapter.
- (c) Chapters may nominate same individual as other Chapters.
- (d) Chapter members may submit letters of recommendation.

#### Surveyors at Large

- (a) A nomination letter with the signature of two sponsors.
- (b) Sponsors must be resident licensed S.C. Land Surveyors.
- (c Recommendation letters from 4 individuals other than the sponsors.
- (d) A minimum of two letters of recommendation must be from SCSPLS members who have been members for at least the two preceding years.

## Data Required Regarding the Nominee in Nomination Letters

- (a) Biographic information.
- (b) Specific contributions to the surveying profession.
- (c) How the Chapters and/or the sponsors recognized the nominee's contributions to the profession.

## Data Required Regarding the Nominee in Recommendation Letters

- (a) Specific contributions to the surveying profession.
- (b) How the nominee's contributions to the surveying profession were recognized.

All nominations and letters of recommendation must be submitted by May 1, 2009.

# C. Selection of Surveyor of the Year

The Vice-President will receive the nominations, review and investigate the nominations. A report and ballot of all eligible nominees shall be mailed to each Board Member and Past President thirty days prior to the SCSPLS Annual Convention. Ballots must be returned ten days prior to convention to be counted. The Vice President, the Immediate Past Surveyor of the Year and the Executive Secretary shall serve as the tellers committee. In the event anyone of these is a nominee for Surveyor of the Year or cannot serve, a replacement shall be appointed by the President. The Surveyor of the Year Award shall be presented at the Annual Convention by the Immediate Past Surveyor of the Year if available.

# Attracting & Retaining the Very Best People

# **By Mike Stones**

Many employers complain about the difficulty of attracting and retaining quality people. When considering this challenge, we must look at what makes people leave their jobs. Profiles International recently completed a survey asking this very question, here are the six main reasons:


- 30% were unhappy with management and the way that they were managed
- 25% felt they received no recognition for good work
- 20% complained of limited opportunities for advancement
- $\bullet$  15% cited inadequate salary and benefits
- 5% were bored with the job
- 5% noted other reasons such as retirement, sabbatical or travel

Are you surprised by the answers? The prevalent theme in these statistics is that people tend to leave people, not jobs.

So what do you do? First, identify and provide training and people information to managers and supervisors who struggle to manage their people in a way that encourages

productivity and retention. Good management is a key to retention. There are a number of avenues available to improve management skills including formal training, mentoring and constant feedback on what they are doing well and what they could improve.

Second, seek out opportunities for positive recognition. Look for ways in which your people perform above and beyond the call of duty. Give as many people as possible an opportunity to bask in the glow of positive recognition for a job well done. But be aware that a recognition culture cannot be created from nothing – it requires a healthy working environment to thrive. Let all of your people know where the organization is going; how it plans to get there; how their jobs play a part in the grand scheme of things and why they are a key to your success. Spread information liberally throughout your organization; give your people an "I'm on the inside" feeling – it's hard to leave something that has you on the inside. Create an atmosphere where management expects the best of its team members and they'll respond. Trust is one of the key sources of recognition



- no one is more flattered than when they are trusted implicitly.

Previous generations of workers could aspire to promotions within multi-layered, hierarchical companies. In these days of lean, flat-structured organizations, workers rarely have this option. This doesn't mean that employers have to accept losing


> staff because they cannot offer a corporate ladder. Today's job-seekers want the opportunity to develop themselves to be all that they can possibly be - to continually polish their skills, abilities and experience so that their value continually rises. If they can do this without the uncertainty of job-hopping, so much the better. You need a clear, ongoing development path – a way that each of your people can advance their skills and value so that they realise their full potential. This means some investment in training and development. Don't be boxed in to limiting the training to those skills specific to an individual's current job. Remember that you are not simply training for job-effectiveness but are also offering your people the development opportunities that make them feel good enough about the pace of their personal advancement that they don't feel the need to look for

greener grass elsewhere.

After following 360,000 people through their careers during a 20 year period, a major study was published by Harvard Business Review. It demonstrated that a key ingredient in retaining people is to ensure that they are matched to their jobs in terms of their abilities, interests and personalities. The study found that when you put people in jobs where the demands matched their abilities, where the stimulation offered by the job matched their interests and where the cultural demands of the position matched their personalities, staff turnover decreased significantly and productivity increased dramatically.

If you can implement the above steps, you will address 75% of the reasons why people leave their jobs. And you haven't added a cent to salaries!



# **Lobbyist Report** South Carolina Society of Professional Land Surveyors

Earlier this fall, we were concerned about a massive change in the regulation of the land surveying and engineering professions when a SC Senate Staffer contacted us about a possible hearing before a subcommittee of the Senate Labor Commerce and Industry Committee concerning changes in the regulation of surveyors and all other regulated professions.

The hearing was postponed indefinitely, and when ACEC-SC PAC checks were delivered to a number of senators, the PAC Board talked to senators about possible changes on the regulation and licensing of engineers and surveyors. The consensus of the engineers reporting back on the conversations was that any possible changes are going to be directed more to the registration and regulation of licensees, which are not as technical or professional as land surveying, engineering, architecture, accounting, etc.

Also, the House Labor Commerce and Industry Committee is expecting a new Chair. Current Chair Rep. Harry Cato (R-Greenville) is expected to be elected to House Speaker Pro Tem. Rep. Bill Sandifer (R-Oconee) may become the next Chair.

From the SC State Board of Registration for Professional Engineers and Surveyors, Surveyor Representative, Mr. Gene Dinkins, was elected Registration Board Chair. Mr. Andy Kinghorn was elected Vice Chair, and Ms. Theresa Hodge was elected Board Secretary.

More important, Mr. Dinkins introduced a curriculum from Clemson University College of Forestry that offers a degree in Forestry with an emphasis area of Land Surveying. Those students following the curricula outlined to meet the Land Surveying emphasis meet the SC State Board of Registration for Professional Engineers and Surveyors requirements for the fouryear surveying degree.

Mr. Dinkins said students had already shown an interest in pursuing the degree. The Registration Board officially endorsed the curricula and the degree at its Nov. 18, 2008 meeting.

Ms. Jan Simpson, Board Administrator, announced all registration board members have submitted the professional development hours for review as if audited by the registration board and all board members met the PDH requirements for the registration period.

Ms. Simpson reported a suggested change to the Regulations had been submitted by a professional engineer representing SCANA, had been reviewed, the LLR legal department agreed and the board accepted the change. The change has been incorporated into the Regulations to be filed with the SC General Assembly prior to its opening day.

Ms. Theresa Hodge introduced a flow chart explaining how the Registration Board deals with complaints. The LLR legal department praised it and said Ms. Hodge had captured the process and portrayed in such a manner that all can understand.

The Registration Board also discussed appropriating funds for surveying and engineering educational programs. Discussions were positive for upcoming programs.

The General Assembly convenes December 2 to elect House and Senate officers, assign committees, offices and other housekeeping duties. Following that meeting, we will know the names of committee chairs and committee assignments. As legislators move up in seniority, they often have the opportunity to move to other committees; therefore, we may see some movement into and out of Labor Commerce and Industry as well as other committees.
