

## **The Duty of the Professional Land Surveyor** Kristopher M. Kline, P.L.S. L-3374



In discussions with other surveyors over the years, I have heard the opinion stated that "If the client just wants a line staked between existing marks (even if placed by the client himself), that the surveyor is justified in marking the line without making any attempt to determine whether or not the line staked is, in fact, the boundary line". To what extent does the responsibility of a professional land surveyor extend beyond merely satisfying the client?

The North Carolina standards of practice clearly require the surveyor to "...conduct the practice in order to protect the public health, safety and welfare." 21 NCAC 56.0701(b) The Rules of Professional Conduct from which the preceding quotation was drawn apply to all professional land surveyors licensed in North Carolina and to all work performed by that surveyor. In addition, the recent changes to 21 NCAC 56.1602(f) now require that "results of a survey shall be reported to the user of that survey as a map or report of survey and, whether in written or graphic form, shall be prepared in a clear and factual manner." This slight change clarifies the principle that all surveying work performed in this state should conform to the Standards of Practice, even seemingly insignificant bits of work such as "just finding one property corner" or "just flagging a line for a fence". In truth, given the common occurrence of lawsuits over property lines in this country, there is probably no longer any such thing as an insignificant survey project.

One argument offered in support of the opening premise of this article has been that "If the surveyor informs the client that no deed research has been performed, that his disclaimer to that effect fulfills the surveyors' responsibility". Unfortunately, this verbal disclaimer is ineffective for three reasons:

(1) The neighboring landowner is unlikely to hear of or understand this abdication of responsibility, and both parties are likely to treat the marked line as the professional opinion of a professional land surveyor;

(2) 21 NCAC 56.1602(c) requires that: "With respect to investigation of property boundaries and recorded easements, the surveyor shall examine the most recent deeds and recorded plats adjacent to the subject property as well as all deeds and plats recorded after the date of the deed or plat upon which the survey is being based (the survey reference deed or plat)." And

(3) The basic responsibilities imposed upon us by licensure cannot be brushed aside by a mere disclaimer (whether verbal or written). During the course of some recent research, I contacted Mr. David Tuttle, board counsel for N.C.B.E.L.S. and asked "if a surveyor can use a disclaimer to avoid doing something that is specifically required by the Standards of Practice". Mr. Tuttle's response was as follows: "A P.L.S. cannot disclaim something that is required by the Standards of Practice or other law. I don't know

of specific references, other than when the Board issued statements in a News Bulletin that surveyors could not put a "Preliminary" on documents that were actually issued as final, just to avoid responsibility for the survey. In a way, that was a disclaimer. To put a disclaimer from something that is required by law is to admit to a violation of the law. That is the best way that I can put it..."

One issue which may become of more concern to the Professional Land Surveyor is the subject of Slander of Title. Although cases of this type involving a surveyor are uncommon, one came up recently in the South Carolina opinion Greene v. Griffith (Unpublished Opinion No. 2004-UP-056 Heard December 12, 2003 – Filed January 29, 2004) This opinion states: "In South *Carolina*, *slander of title has been recognized as a common law* cause of action. See Huff v. Jennings, 319 S.C. 142, 148, 459 S.E.2d 886, 890 (Ct. App. 1995) (holding that, although the court was directly addressing a claim for slander of title for the first time in South Carolina jurisprudence, "South Carolina law, through its incorporation of the common law of England, recognizes a cause of action for slander of title"). To maintain a claim for slander of title, our courts have held "the plaintiff must establish (1) the publication (2) with malice (3) of a false statement (4) that is derogatory to plaintiff's title and (5) causes special damages (6) as a result of diminished value in the eyes of third parties." Id. at 149, 459 S.E.2d at 891 (adopting the elements of slander of title outlined in the Restatement (Second) of Torts § 623A (1977))."

This case demonstrates the consequences of placing the whims of the client over our responsibility as professionals to survey boundaries as described in the relevant title documents. In this case, the surveyor prepared a recordable plat indicating that his client (Griffith) owned a tract of land. According to the court record, the surveyor based his work purely on the statement by Griffith that "... the tax office said I owned [the strip of land in question]." [The surveyor] *testified that, when he prepared the plat, he had no* evidence that Griffith had any ownership interest in the disputed strip. The practical impact of this case on both Griffith and his surveyor was substantial enough; Griffith was required by the court to pay damages of \$55,676.62.

A recent court proceeding in North Carolina also highlights the issue of the duty of surveyors in protecting the public health safety and welfare. This case hinged on the location of a boundary line which could be convincingly located on the ground based on the existing legal descriptions, but was at odds by some 80 feet with a curving fence of uncertain origin. A surveyor had originally produced a plat of survey showing the boundary line in question in a location consistent with the monuments called for in the deed descriptions, but later produced a new plat showing the boundary line along the existing fence, with no indication of any possible overlaps or gaps. A quitclaim deed was recorded based on the later survey, which became a contributing factor in events which led to a jury trial over a week in length.

Professional land surveyors have, for many years now, lamented the lack of respect accorded to our profession. My attention was caught by an email from Donald A. Wilson which

showed up in my box last April; in it, he said that the public "... will not bestow upon surveyors what we do not deserve no matter how much we jump up and down and thump our chests." The cases cited above may help illustrate why we are not always treated as professionals, and may also provide a clue as to how we should practice our profession in order to earn the respect of the public. At the least, we can see that failure to perform up to a minimum standard can have drastic repercussions.

The members of NGAC report to the chair of the Federal Geographic Data Committee (FGDC), the federal interagency executive group responsible for providing leadership and direction in federal geospatial programs. The FGDC is chaired by the Secretary of the Interior or the Secretary's designee.



The public is invited to comment and make suggestions at all committee meetings, which will be announced by publication in the Federal Register at least 15 days before the meeting date. The U.S. Geological Survey, a bureau of the Department of the Interior, provides support services for the NGAC. The NGAC functions solely as an advisory body.

The NGAC was created under the Federal Advisory Committee Act, which was enacted by Congress in 1972 to ensure that advice rendered to the executive branch by advisory committees, task forces, boards, and commissions formed by Congress and the President, be both objective and accessible to the public. The Act formalized a process for establishing, operating, overseeing, and terminating these advisory bodies.

#### SC COUNCIL OF ENGINEERING & SURVEYING SOCIETY: No report.

**NSPS:** Mr. Henry Dingle's written report stated the ACSM Fall Conference was held in Orlando, FL in conjunction with the ASPRS / CaGIS 2010 Fall Specialty Conference November 13 - 16, 2010. The following issues were discussed at this conference:

- A new set of ACSM / ALTA standards have been endorsed by the Board of Governors and approved by the Board of Directors of NSPS. They will go into effect on February 23, 2011.
- Introduced a motion that was approved by the Governors and Board of Directors to issue a letter in support of our State Board of Registration in their Cease and Desist Order to DHEC.
- The National Museum of Surveying opened on September 25, 2010 in Springfield Illinois.
- The 2010 National Jamboree Surveying Merit Badge was a success with 109 scouts completing the badge. Surveying Merit Badge Geocoins will be sold at \$25 each to help defray the costs of the next efforts. Any states supplying the \$695 amount to sponsor Youth Staff will be presented with a commemorative coin. The 2013 Jamboree will be in West Virginia. #### FALL 2010 JOINT GOVERNMENT AFFAIRS **COMMITTEE MEETING - SEMI-ANNUAL REPORT** ORLANDO, FL

FEMA Flood Map Modernization / Risk MAP: As part of the FEMA Flood Map Modernization Coalition, we worked with other groups and FEMA for the modernization of the Nation's flood maps. FEMA has moved from its Map Modernization Program to its Risk MAP Program. Under the Risk MAP, FEMA will try to (1) address gaps in flood hazard data, (2) increase public awareness and understanding of flood risks, (3) lead and support state and local communities in risk based mitigation planning, (4) provide an enhanced digital platform that improves management of Risk MAP and (5) align Risk Analysis programs to enhance decision making capabilities. The Coalition continues to meet with FEMA representatives on a quarterly basis to receive updates on the FEMA floodmap activities. FEMA will soon roll out 3 new products relating to FIRMs, including a Flood Risk Database, Flood Risk Reports, and Flood Risk Maps, which will be a subset of the Flood Risk Report. COFPAES: We continue to work with the other COFPAES member organizations to protect and defend the Brooks Act. Several times this year, COFPAES was able to turn around

Brooks Act violations by federal agencies. COFPAES had its Fall Delegate Meeting in November. Here are some highlights:

- **GSA Schedule** COFPAES staff met with the law firm of Crowell and Moring to discuss a strategy for rescinding or reforming the GSA Schedules affecting A/E services in violation of the Brooks Act. Crowell Moring provided a proposal for COFPAES' consideration. The cost for the services would break down to about \$2500 per COFPAES Member Organization. Although ACSM supports the concept, we are not able to contribute at this time.
- SBA Size Standards The Small Business Administration is planning to review its size standards in the A/E field in 2010. SBA has not been able to keep the timetable it expected, and it is doubtful the review will take place in 2010.
- Water Resources Development Act The House Transportation and Infrastructure Committee has under consideration H.R. 5892, the Water Resources Development Act. Included in the Act is a provision that would define all operations and maintenance activities as "inherently governmental", thus ineligible for performance by private contractors, affecting surveying, hydrography and mapping.

Lobby Day 2010 (review) and Lobby Day 2011: As you know, NSPS lobbied Members of Congress on three issues: Preservation of Railroad Monumentation issue, the 3% Withholding on Government Contracts issue, and Funding for Trig-Star. Overall, the reports we received indicate the issues were well received and supported. The biggest hurdle is educating Members of Congress about the Preservation of Railroad Monumentation issue. Once Members of Congress understand the issue, most of them agree it makes sense and often support it. If you live in a District or State that has a new Representative and/or Senator, it may be a good idea to pay them a visit, congratulate them on their win and tell them about our issues. We are in the process of working out the details of our Lobby Day for 2011.

3% Withholding of Payments on Government Contracts: ACSM is a member of a coalition called the Government Withholding Relief Coalition. The coalition is comprised of approximately 70 business associations working together to repeal Section 511 of the Tax Increase Prevention and Reconciliation Act of 2005. A full repeal of Section 511 was in place in the House passed version of H.R. 1, the "American Recovery and Reinvestment Act of 2009", but the final bill, signed by the President only provided for a one year delay in the provision's enactment (now set at 2012). The Coalition is still working on full repeal of the provision and legislation was introduced in the House and the Senate to accomplish that goal; S. 292 in the Senate (introduced by Senator Specter) and H.R. 275 in the House (introduced by Congressman Meek of Florida). Neither of these bills got very far this year. The Coalition has drafted a letter to be sent to the House and Senate urging a twoyear delay of the 3% withholding requirement during the lame duck session, while stressing the continuing need for repeal. Preservation of Railroad Monumentation: The preservation

of railroad monumentation has been a big issue this year. We met with the staff for many Members of Congress, as well as key Committee staff in the House and the Senate. The biggest obstacle has been educating staff on the issue. Once they understood the issue, most agreed it made sense. Our secondary problem (which is becoming bigger) was showing how it would be paid for. A few of the staff we spoke with called back after our initial meeting and said the railroad people they spoke to subsequent to our meeting opposed the idea, and would push back against it because of perceived costs. Most reports that came back from the Lobby Day visits were positive on this issue. We were able to follow-up on all of the reports we received so far, and several Members of Congress want us to follow-up with them in January.

At this point, there are 4 possible ways to move forward with the issue:

- 1. push it as a Stand Alone Bill, this means continuing to move it forward as we have been doing;
- 2. include as part of Other Railroad Legislation, we were working on this avenue last year, but very few railroad related bills were introduced (and those that were introduced were not a good fit):
- 3. include it as part of the <u>Surface Transportation</u> Reauthorization, this seems to be the best way to go, since several staff contacts advised us to go this route; and
- 4. include it as part of a bigger Jobs Bill, this would remove the payment objection because theoretically, Congress would give money to states and localities to hire surveyors to survey the railroad lines before they are removed. Several people we met with liked this idea as well.

There is nothing preventing us from promoting all four ways together.

USGS Coalition (Information Only): The main goal of the Coalition continues to be working with Congress for sufficient funding for USGS so that it can continue its mission. We met with a number of high ranking USGS and Dept of Interior officials throughout the year and recently were told that they expect the USGS funding to be severely cut in FY 11. Our job is to work with the Coalition to make sure mapping programs in the USGS continue to be funded.

Funding for Trig-Star (Information Only): Our request for a Federal earmark for Trig-Star was denied by the Maryland Congressional delegation. Although we were not given a reason for the denial from Rep. Chris Van Hollen's office, Senator Barbara Mikulski told us the reason for her denial was we noted in our application that we were looking for funding for consecutive years and not putting a lot of our own money into the project. We did receive a lot of support for the program from Reps. and Sen. in Districts and States outside of Maryland. We will revise our application and seek funding assistance from the Members of Congress who voiced support for the program. We are continuing to look for other funding opportunities through grants with the NSF and Dept. of Education. I encourage you again to give us names or help make contact, so we can get Trig-Star in our schools. There is scholarship money available for the kids.

STEM Coalition: ACSM has recently joined the Science,						
Technology Engineering and Mathematics (STEM) Education

Technology, Engineering and Mathematics (STEM) Education Coalition and signed a letter from the Coalition to Senators in support of the America COMPETES Act. The America COMPETES Act, already passed in the House, bolsters America's competitiveness by strengthening the science, technology, engineering, and math education fields at all levels. It gives support for basic research and development programs in the STEM fields in elementary and high school. As part of STEM Education Coalition, we join over 1,000 diverse groups representing all sectors of the technological workforce. Through our affiliation with the Coalition, we hope to secure Trig-Star funding by finding broad support with STEM Coalition members who can help us gain support in Congress.

NRCS Brooks Act Violation: In Missouri, the USDA Natural Resources Conservation Service (NRCS) sent a Scope of Services document to landowners involved in Wetlands Reserve Program Boundary Surveys. Under the Scope of Services, and at the request of the NRCS, landowners must submit a statement of survey cost (a quote) to the NRCS Agency Liaison. NRCS will review the quote and, if it is found be acceptable; it will be incorporated into the Survey Cooperative Agreement. If the quote is not acceptable, NRCS will ask the landowner to obtain two additional quotes. The NRCS must approve the survey cost for the landowner to be eligible for reimbursement. ACSM is concerned this procedure violates the Brooks Act, which requires that surveying services (as well as other A/E services) be procured by federal government using Qualifications Based Selection procedures. In this case, it appears NRCS is circumventing the Brooks Act process. It is the landowner who is hiring the surveyor; but the NRCS must approve the

surveyor – and approval is based on the price for the surveyor's services. This issue was brought up at the COFPAES meeting on November 10. We are trying to determine if this is an issue in other states. If you experienced this kind of price requirement from a federal agency for your surveying or mapping services, let us know about it.

National Surveyor's Week Proclamation: At our last JGAC meeting we discussed the problem we faced with getting a National Surveyor's Week Presidential Proclamation and that we are being denied because the third week of March is also National Poison Prevention Week. Since that time, we looked to see if there were any weeks in February or March that would not have a conflict. Right now, the second and third week of February contain no conflicts. If we would like to pursue a Presidential Proclamation, those may be the best weeks to do it. JGAC Issues Survey: We are in the process of putting together an 'issues survey' which would go to all ACSM members and ask them what legislative issues are important to them. If members tell us the issues that are important to them, it will inspire them to become more involved in JGAC activities. Look for the survey soon.

New Congressional Forecast: The new Congress looks to be very pro-business. One of the newly elected House members is an engineer and another is a construction project manager. The next meeting will be in San Diego, CA, July 9 - 12, 2011 at the joint ESRI - ACSM Survey Summit. President Swygert will write a letter to the membership which will be emailed. Aetna has written letters to the members who signed up for additional insurance.

pre-filing has just begun. SCSPLS lobbyist Joe Jones is tracking any issues that may impact out profession. Only one bill has been pre-filed of interest, and that is the tort reform bill in the Senate. Also John White, State Engineer, said the Budget and Control Board was going to have a procurement code bill filed; he did not say if it would be pre-filed before the session opens. Mr. Jones plans to find authors between now and January to reintroduce the QBS bill that was introduced last year. A few surveyors are needed to meet with Senator Jake Knotts asking him to support the tort reform bill that was introduced. He has responded by letter that he would like to sit down with some engineers and surveyors and discuss tort reform. Joe Jones would like to put together a couple of surveyors and engineers to meet with him this month if possible. Any surveyors that are in his district with any connections to him personally should contact Dennis Johns. Sen. Knotts has voted against Tort Reform in the past and sits on the Judiciary Committee where tort reform always gets killed in the Senate. He is close to trial lawyers but we would like to show him surveyors and engineers are people who vote and make contributions. As for PAC, we are getting the ball moving to start this for SCSPLS. This will take more time to set up for it to be successful and get the money and PAC board members set up to. We hope to have some events next year for the contributions to begin. The survey affidavits issue has been talked about with our group and the attorneys. I ask each of our members to please work through our SCSPLS on all State matters and keep us informed on local matters so that we may all work together for a stronger common good for our profession.

Membership: Mr. Kent Hudson's written report stated that there are currently 429 members: Full – 353, Associate – 22, Complimentary – 14, Emeritus -24, Student – 1, Sustaining – 15. At this time last year, SCSPLS had 459 members (378 Full, 28 Associate, 12 Complimentary, 24 Emeritus, 2 Student and 15 Sustaining.) There are no new applications for approval at this time.

Newsletter: No report.

Past President's Council: No report.

Plat Contest: No report. Winning plats for 2010 will be sent to NSPS for their map contest of 2011.

Public Relations: No report.

SC State Parks: Mr. Mike Culler reported that there is no new activity on the state parks and surveys are winding down on this project.

Scholarship: Mr. Robert Praete announced the raffle of a day of Wild Turkey and Wild Boar Hunting at Cypress Creek Plantation in Estelle. Tickets are \$5 for one and \$10 for 3. This will be given away at the Education Conference in Columbia in February. The committee is also looking at several other items to raffle at the convention in June.

Survey Contest: No report. The Aiken Chapter is in charge of the games this year.

Surveyor of the Year: No report. Yearbook: No report.

#### **BUSINESS:**

Board of Prof. Eng. & Surveyors: Mr. Gene Dinkins and Mr. Thurl Amick presented the recent activities of the State Board of

Professional Engineers and Surveyors.

Companies which advertise to coordinate surveying services for a fee have come to the Board's attention. These companies send leads to surveyors that have registered with them for a fee. That fee could be considered a commission, and it is illegal for surveyors or engineers to pay a commission to bring in work. Please be aware of this illegal practice. The Board has no jurisdiction if the company does not have a COA or individual is not licensed. The complaints should be sent to the LLR Board attorneys and they will file a complaint which will go the Administrative Law Judge for review and a if a decision is made for the company to stop their practices, a cease and desist notification will be sent.

Mr. Amick discussed Construction Staking. There are groups in South Carolina forming their own construction staking company, without a COA, to obtain construction staking jobs. In the codes, construction staking is defined as a part of surveying. This issue has not been voted on by the full State Board.

A new one-hour open book examination has been adopted for competency for understanding the statutes of the rules and regulations for surveying and engineering.

Head of the Legal Conference continues to have face to face meetings on the deficiencies of the LLR Board of Registration. The IRC (Investigative Review Committee) reviews the complaints sent to LLR. Mr. Rick Inman is the PLS member on this committee. They are in the process of developing guidelines for the committee members.

Mr. Dinkins received a letter from head of the Legislative Audit Council and subsequent meeting concerning the LLR staff support and organization changes. Responses will be presented to the LCI (Labor, Commerce and Industry) Committee in the next legislative session. With a new Governor being sworn in, a new head of LLR will be appointed.

Survey Affidavits: Last year the head of the SC Bar Real Estate Committee agreed to recommend survey affidavits no longer be used at closings. The SC Bar Board of Governors refused to eliminate the survey affidavits. Mr. Dinkins requested an update on this issue. Response was not very promising and stated that he is not sure the Legal Bar will approach this issue any differently from last year since there has been little turnover on this board.

In December 2009, DHEC put out an RFP to gather information on the Dunes lines. The RFP indicated a PLS was not required, however, the information they are asking for is equivalent to a hydrographic/topographic survey. The Board of Registration sent a letter to DHEC notifying them a PLS was required for the information they were requesting. Despite the opinion of the Registration Board, Coastal Carolina University was awarded the contract by DHEC. Coastal Carolina University does not have a PLS on staff and does not have a COA and will be using students for this project. Because of advanced technology, students are able to do the work for this project at a low price. The data being collected will be used in long range hurricane and emergency preparedness plans. After several letters between DHEC and the Board of Registration for Engineers and Surveyors, DHEC continued with the project using Coastal Carolina University students. A Cease and Desist letter

was sent to Coastal Carolina University. After repeated contact between DHEC and the State Board, DHEC has issued a Request for Contested Case hearing. There will be an opportunity for testimony to be heard from professional associations, firms, and individuals at a hearing held December 10<sup>th</sup>.

March 2011

The State Board has approved financing for the speakers for the SCSPLS February conference.

Mr. Dinkins mentioned that the national testing administered by NCEES has decreased nationwide. Normally, NCEES gives around 2,000 FS exams but as of October of this year, the number was down to 1,200. They normally administer 1,100 PS exams, but this years total was around 600. Many surveyors are getting out of the profession so it is important that we educate the registered surveyors and encourage more to enter the profession.

Mr. Dinkins mentioned the possibility of having a reference library for those interested in taking the surveying license testing. The board will help fund review courses for licensing. Mr. Dinkins asked the Society to review this idea and get back with him on any additional ideas.

President Swygert thanked Mr. Dinkins, Mr. Amick, and the Grand Strand Chapter for providing the beer for the golf outing on Friday, December 3, 2010. He also thanked all those in

attendance for their support of the Society. With there being no further business, motion was made to adjourn with a second. Motion unanimously approved.

This has been a long fight dating back many years and we are glad that this important rule has been passed. Our thanks and congratulations are owed to Timothy Davis, who has worked on this for the past year and made sure it did not get forgotten.

### **2011 ALTA/ACSM Land Title Survey Standards**

The new 2011 Minimum Standard Detail Requirements for ALTA/ACSM Land Title Surveys went into effect February, 23, 2011. The 2011 Minimum Standards represent the latest and 8<sup>th</sup> version of the Standards which were last revised in 2005. It is also the first major rewrite of the Standards since their initial adoption in 1962.



#### **Seminar Descriptions:**

"Anyone Could Lead Perfect People – If There Were Any" ... But there aren't any! Myriad books on leadership and management have been and continue to be published. ## LOBBYIST REPORT

South Carolina Society of Professional Land Surveyors Joe S. Jones

The General Assembly is off to a fast start this year. Hundreds of bills have been filed, and committees are meeting to move some of these bills through the system.

Perhaps the most interesting to surveyors is H.3571 which was filed Feb. 2. 2011. This bill is the result of a cease and desist order issued by the Department of Labor Licensing and Regulation to Coastal Carolina University.

This order was issued to stop Coastal Carolina University from conducting "surveying" for the SC Department of Health and Environmental Control. DHEC had contracted with CCU for the services. I understand the university was going to use student manpower for much of the actual field work. And CCU did not have a registered surveyor on the project.

A hearing was held before an Administrative Law Judge where LLR, CCU and DHEC presented their positions to the judge. An order from the judge has not been rendered, but some feel LLR had made the case that the work described in the contract was surveying and required surveyors to conduct the work.

The bill, if passed, would basically give DHEC an exemption to the state law regarding surveying dealing permit applications within coastal tidelands or wetlands and allow the agency to contract with organizations who are not surveyors.

This bill amends Chapter 48 of the state statutes: "Environmental Protection and Conversation." This language is not placed in the Engineering and Surveying Statute.

The sponsors of this bill are Alan Clemmons (R-Horry) who serves on the House Judiciary Committee: Dwight Loftis (R-Greenville) who serves on the House Ways and Means Committee; Phyllis Henderson (R-Greenville) who serves on the House Medical, Military, Public & Municipal Affairs Committee; Christopher Murphy (R-Dorchester) who serves on the House Agriculture, Natural Resources and Environmental Affairs Committee, and G.R. Smith (R-Greenville) who serves on the House Judiciary Committee.

Ms. Henderson is new to the House: she took Rep. Bill Wylie's seat in November and Mr. Murphy, also new, replaced Rep. Annette Young in November. Notice only one of the sponsors of this bill serves on the Agriculture, Natural Resources and Environmental Affairs Committee. and he is new representative Christopher Murphy.

Representative Nelson Hardwick, PE, is Chair of the Agriculture, Natural Resources and Environmental Affairs. He has always been our friend; however, he is from Horry County as well.

This bill is assigned to the Environmental Affairs Subcommittees I whose members are David Hiott-Chairman, Bill Crosby, Chandra Dillard, and Chris Murphy.

This bill is relatively short. Here is the bill without the lengthy title: H. 3571

"Be it enacted by the General Assembly of the State of South Carolina: SECTION 1. Section 48-39-140(B) of the 1976 Code is amended to read:

"(B) Each application for a permit shall be filed with the department and shall include:

(1) Name and address of the applicant.

(2) A plan or drawing showing the applicant's proposal and the

manner or method by which the proposal shall be accomplished.

(3) A plat of the area in which the proposed work will take place: any requirement beyond a standard boundary survey of this area must be governed by regulations promulgated by the department pursuant to the Administrative Procedures Act.

(4) A copy of the deed, lease or other instrument under which the applicant claims title, possession or permission from the owner of the property, to carry out the proposal.

(5) A list of all adjoining landowners and their addresses or a sworn affidavit that with due diligence such information is not ascertainable."


SECTION 2. This act takes effect upon approval by the Governor."

The SC State Board of Registration for Professional Engineers and Surveyors are expected to oppose this legislation. As your lobbyist, I suggest SCSPLS oppose this legislation as well.

I have checked with the Committee Staff and learned this bill may be put on a subcommittee agenda the week of Feb. 21 in which case SCSPLS must have its positions clearly stated and surveyors lined up to testify.

Make no mistake, DHEC is formidable opposition. I am sure they are telling legislators this bill is needed because the department and the state have very limited funds to pay for such projects.

As this legislation should be of high priority for SCSPLS, I will briefly mention issues should be of interest: Qualification Based Selection for all public work, from state government to political subdivisions, Tort Reform were introduced last year and did not pass. In addition to these two bills, I am working on a bill for engineers that you may be interested in also. Senator Cromer is working on a bill to wave professional development hours for military on overseas duty or in combat zone duty.




## **Surveyors and Scouting**
