



# THURSDAY CONVENTION SEMINAR:

# "MINIMUM TECHNICAL STANDARDS - GEORGIA"

Matt Wilson, RLS, Southern Polytechnic State University

Thursday, July 17<sup>th</sup>, 8:00 AM – 12:00 PM (4 PDH for Georgia Licensees)

Matt is a Professor in the Civil Engineering Technology Department at Southern Polytechnic State University and the Program Coordinator for the Surveying and Mapping degree program. Matt has been licensed in Georgia and has consulted as a land surveyor since 1996. He just completed his 19th year with SPSU, and he enjoys bicycling and running.

Georgia has had many changes to the OCGA over the last few years. The Board rules change fluidly. This seminar will bring you up to date with the rules and laws affecting land surveying in the state of Georgia. Are you aware that Surveyors are now supposed to sign plats in contrasting colors to their stamp? Can you record exempt subdivision plats? How do the new rules change the way you do business? ## "POSITIONAL TOLERANCE"

Dan Branham, Southern Polytechnic State University Friday, July 18<sup>th</sup>, 8:00 AM - 9:00 AM (1 PDH)

This course will discuss statistics and positional error analysis. The state standards and ALTA standards both list positional error tolerance as a means to express the accuracy and precision the signing surveyor achieved with the measurements used in the survey. Attendees should leave this course with a good knowledge of positional tolerance and how that applies to these standards using GNSS or optical equipment.

Daniel Branham, RLS is a Georgia Registered Land Surveyor and a Surveying lecturer at Southern Polytechnic State University. He is the faculty advisor for the NSPS student competition 2014 champions. # "TERRESTRIAL PHOTOGRAMMETRY FOR LAND SURVEYING, GIS, ARCHITECTURE, & CONSTRUCTION"

Terrestrial Photogrammetry is an emerging technology in the surveying and mapping profession. ## "GPS ON BENCHMARKS CAMPAIGN"

Lonnie Sears, RLS, eGPS Solutions, Inc. Friday, July 18<sup>th</sup>, 11:00 AM – Noon (1 PDH)

The National Geodetic Survey (NGS) encourages anyone with survey-grade Global Positioning System (GPS) receivers to join the 2014 GPS on Bench Marks Campaign improving the National Spatial Reference System (NSRS). NGS will use your data to improve the next hybrid geoid model, increasing access to NAVD 88 (the North American Vertical Datum of 1988) and enabling conversions to the new vertical datum in 2022. This course will demonstrate the field and office procedure to successfully submit data for improvement of the geoid. The program will greatly improve the ability to use GPS/GNSS equipment to establish accurate elevations. It will also show attendees a new database of monuments other than the typical datasheet.

Lonnie Sears brings over 30 years of surveying experience to eGPS Solutions, Inc. He started his GPS career in 1990 as the GPS Project Manager with a national firm located the Atlanta area. His background has been devoted to developing GPS Surveying techniques for GIS inventory projects, DOT projects, private land development projects, Large Boundary Surveys, ALTA/ACSM Surveys and Topographic Surveys. # Drone Technology and Its Effect and Opportunities on the Land Surveying, Mapping, and GIS

Drones will have a dramatic impact on the mapping, design, and construction industries. The amount of people collecting aerial data will explode. However it is not the aerial platforms that collect the data that are important but the ability to take these machines and create useful data. The course will review the current technology and capabilities of UAV's (drones). In addition to their ability to collect close range aerial photography the course will discuss the new term of Pixelgrammetry and how drone photography can be used to create survey grade data, something that Surveyors, Mappers and GIS professionals have been doing for years. The course will look at the different capabilities of the "copters" and the "fixed wing" aircraft and their advantages and capabilities. The instructor will also propose some likely new work flows the average land surveyor Mapper or GIS professional can use to reduce cost and increase data collection capabilities. It will also include information on how these systems are being used currently in other industries that may provide opportunities that currently do not exist in these industries.

Tate Jones has over 40 years of experience in Land Surveying, Aerial surveying, 3D Laser Scanning, and Lidar technology. A graduate of Auburn University, Mr. Jones holds a professional surveying license in Alabama, Georgia, South Carolina and Florida. He has authored various articles on the science of laser scanning and is a nationally recognized speaker on the subject. He has also served on the editorial boards of POB surveying magazine and Professional Surveying magazine and is a contributing editor on topics related to Lidar and 3D laser scanning. Mr. Jones has followed the small UAV industry for the last 3 years and studied the advancements of the technology. His background of Aerial Mapping and Land Surveying and Lidar technology has allowed him to take a "surveyors view" of the future impact these new flying data collectors will have in the world of surveying. Mr. Jones has been flying UAV's for the last 2 years as a hobby while concurrently studying their use and effect on the Land Surveying, Aerial mapping and Construction Industry. He recently published an article on the subject for The Georgia Engineer Magazine.



The network provides real time corrections to both the US GPS and the Russian GLONASS satellites. Data sets are also stored for approximately 5 days in the Receiver Independent Exchange (RINEX) format. This can be modified if needed. Contact Matt Wellslager for that request. SCGS has 45 receivers operating within SC. There is one in Augusta, GA that SCGS maintains and 9 operating in NC that SCGS receives data from. Counties that do not have a reference station operating include: Allendale, Chesterfield, McCormick, and Abbeville. Attempts were made to get a reference station up and running in Chesterfield, but problems with the internet connection and service have been a problem. SCGS is working to get that issue resolved. SCGS is

replacing the original receivers with the latest technology offered by Trimble, the GNSS NetR9 receiver. The NetR9 receiver provides to the SCGS the ability to create corrections to the L5 and L2C signals when they are made operational. The NetR9 also has the architecture in place to provide corrections to the European Galileo constellation when that becomes operational.

Membership to the network is growing. In the last fiscal year, the SC RTN had 471 members. Of those, 213 were Professional Land Surveyors. That indicates an increase of 29 surveyors from the previous year, or a 5% growth.

An interesting issue was brought to light back in December for users working with the RTN. A firm discovered they were seeing a 2.5 foot offset between coordinates they had established earlier that year and observations they were collecting in December. The only difference between the first set of observations and the second was an update in the data collection software they were using. As it turned out, the new software updates had a projection for the 2011 adjustment. This projection included datum updates from the 2001 and 2007 adjustments as well. Knowing they needed to work with the 2011 datum, they selected the 2011 projection at for data collection and started checking into existing control. All of the data in the SC RTN is constrained to the 2011 datum. All of the reference stations have 2011 coordinates and ellipsoid heights. When collecting data in the field using the SC RTN, SCGS suggests collecting data using NAD83 (86). That will not add any adjustment to the data.

performing various types of surveys for use in construction of boat ramps. In the article it seems they are surveying on their own, but we have found out they are working under a licensed surveyor. There is still some question about the supervision of the crews but they seem to be operating within the law. SCSPLS will continue to monitor.

**Elevation Certificates Online:** SCSPLS was notified by a member that counties were beginning to put all Elevation Certificates online. Concerns about the certificates being offered online were discussed among the group. Manipulation of the original certificate was discussed as a potential problem. The larger concern was for insurance companies issuing flood insurance based on elevation certificates prepared for previous property owners instead of getting a new certificate done when the property changes ownership.

**June Meeting Date:** The final General Membership meeting date of the 2013-14 fiscal year will be June 6, 2014, at the Riverbanks Zoo & Gardens. There will be a board training session for 2014-15 board members at this meeting. Chapters were asked to have the names of their 2014-15 officers sent to the SCSPLS office prior to the June meeting date.

PAC: Mr. Dennis Clinkscales reported that he and Kim Long have gotten a price from Jim Ritchie, Esq. for the set-up of an SCSPLS PAC and yearly PAC audit. The price is \$2,500 per month for the next 3 months, which is the time it should take to set up the PAC. After the initial 3 month set-up time is passed, SCSPLS can renegotiate with Mr. Ritchie for a yearly audit. It is a lot of money but Mr. Ritchie is very qualified in this area. In addition to filing the necessary paperwork to get started, Mr. Ritchie will work on the PAC By-Laws and board structure. The PAC Board will be separate from the SCSPLS board. Contributions would be sent directly to the SCSPLS office and deposited into a separate account designated solely for PAC funds. The initial attorney fees can come out of the SCSPLS general operating account and in the future there will be an option of paying out of the SCSPLS general operating account or out of the PAC account. SCSPLS does not have money set aside in the current budget to pay the \$7,500 to get the PAC going, but the Society is strong financially overall and if it is the best path forward for the profession, it should be considered. The group discussed the benefits of having a PAC, making sure it was run correctly and making sure it could be sustained over a period of time. They also discussed possible issues that can be addressed through a PAC. Contributions cannot be made until an account has been set up and rules on accepting contributions will have to be followed. A motion was made to spend the funds required to start the process of getting the PAC going and contract with Jim Ritchie, Esq. Motion received a second and passed unanimously. Reference to Deceased or Retired Surveyors: Mr. Bobby Foster asked the group to consider ways that surveyors can keep attorneys, realtors, etc., from referencing old plats prepared by deceased or retired surveyors in deeds. It is a problem that is getting worse. Various ways of addressing the issue were discussed. Tennessee and North Carolina have been able to pass laws in their respective states that may give South Carolina some direction on where to start. Using the time frame specified in the Statute of Repose was mentioned as a possible cut-off number for referencing plats.

**Closing Comments**: Mr. Thurl Amick stated there was a lot of discussion at the meeting regarding the PAC and various issues affecting surveyors. He expressed to the group the need to make sure the Society moves forward to make things happen for the profession.

President Aaron Leach thanked everyone for attendance and encouraged them to stay and attend the Chapter cook-off.


