PURPOSE

The S. C. Society of Professional Land Surveyors (SCSPLS) was formed to advance the public welfare and the professional, social and economic interests of the Land Surveyor by promotion of education, legislation and public relations through the establishment and maintenance of high ethical standards and practices. It is proposed to bring about coordination between the Land Surveying and Engineering Professions through close cooperation with representative organizations of Professional Engineers.

MEMBERSHIP CATEGORIES

SCSPLS Membership year is from July 1 through June 30 of each year.

\$205.00 per year for Full, resident members plus \$10.00 application fee = \$215.00

\$165.00 per year for Full, out-of-state members plus \$10.00 application fee = \$175.00

\$200.00 per year for Sustaining members plus \$10.00 application fee = \$210.00

\$ 65.00 per year for Associate members plus \$10.00 application fee = \$75.00

\$ 10.00 Complimentary application fee

\$ 25.00 per year for dues for Student members, Application fee waived = \$25.00

Emeritus Members = dues exempt.

FULL MEMBERS

Professional Land Surveyors who are of good standing in South Carolina or any state or territory of the United States that regulates the practice of land surveying and the licensing of Land Surveyors. Full, resident members of SCSPLS are automatically members of the National Society of Professional Surveyors and entitled to all privileges and benefits of NSPS membership. They are also represented on a national level by an NSPS Governor and NSPS Representative.

Annual Dues: \$205.00. Application fee: \$10.00.

ASSOCIATE MEMBERS

Land Surveyors in Training and any person who is working toward registration as a Land Surveyor and has not qualified for the exams may become an Associate Member of the Society. Associate members shall have all rights and privileges of membership except the holding of office or balloting in the election of officers. Associate members whose legal residence is in South Carolina are allowed to take part in the NSPS membership program on an optional basis at the current rate of \$40, in their appropriate NSPS membership category.

Annual Dues: \$65.00 (\$105 if participating in NSPS Membership program). Application fee: \$10.00

SUSTAINING MEMBERS

Any commercial or professional institution or individual interested in surveying and mapping, the manufacture of instruments or equipment for this work or the production or compilation of maps. Sustaining members shall have all rights and privileges of full membership except the holding of office and voting.

Annual Dues: \$200.00. Application fee: \$10.00

EMERITUS MEMBERS

Any member who has reached the age of 65 and has been in good standing for 15 or more consecutive years with SCSPLS may apply for Emeritus Membership subject to approval by the Board. Emeritus members have all rights and privileges of full membership. Emeritus members whose legal residence is in South Carolina are allowed to take part in the NSPS membership program on an optional basis at the current rate of \$40, in their appropriate NSPS membership category.

Annual Dues: Exempt (\$40 if participating in NSPS Membership program).

HONORARY MEMBERS

The Board may bestow upon any person, who has rendered acknowledged eminent service and who has made valuable and outstanding contributions to the profession, the title of Honorary Member. Honorary members shall have all rights and privileges of full membership except the holding of office and balloting in the election of officers.

Annual Dues and Application Fee: Exempt.

STUDENT MEMBERS

Any student of a school of higher education recognized by the Board of Directors who is interested in Land Surveying or related professions. Student members shall <u>not</u> be eligible to vote or to hold office in the Society. Transcript copy must be included with your application. Student members of SCSPLS can qualify to be included in the NSPS Membership program at the current rate of \$10 starting with the 2014 membership year.

Annual Dues: \$25.00 (\$35 if participating in NSPS Membership program). Application fee waived.

BENEFITS OF MEMBERSHIP

NSPS Membership

Full SCSPLS members that are residents of SC are automatically members of the National Society of Professional Surveyors and entitled to all privileges and benefits of NSPS membership, including exclusive insurance programs. SCSPLS members are represented on the national level by an NSPS Governor and Delegate that is elected by SCSPLS members. NSPS monitors legislation on the national level (i.e. Lightsquared, Davis-Bacon Act, etc.), and holds a Lobby Day each year.

SCSPLS Convention & Technical Conference & Trade Show

The SCSPLS holds an annual convention each year. Attendees exchange ideas, hear guest speakers for related professions and socialize at planned events and meals. The annual business meeting is also held during the convention. Lifelong friendships are begun and renewed at the Convention. Scholarship


The Society is proud of the scholarships awarded in the past and will continue this program to assist land surveying students in their educational goals.
